#### THE FOSTER CARE CRISIS IN WEST VIRGINIA

West Virginia has the highest number of children in the foster care system per capita. For every 1,000 babies born in West Virginia, 24.6 are removed due to maltreatment. This is more than three times the national average of seven per 1,000.

#### TRAUMA FOR CHILDREN IN FOSTER CARE

Over 60% of children in foster care are removed due to neglect. In West Virginia, it is estimated that 85% of child cases involve drug use. Over 60% of children in foster care will experience seven or more school changes.

### A DESPERATE CALL FOR FOSTER FAMILIES IN WEST VIRGINIA

Advocates consistently report that there is an insufficient number of foster families to care for these children. 80% of families who foster stop fostering within two years. Without support and care, the future for these children can be bleak.



Former foster youth are **2X** more likely to suffer from PTSD than combat veterans.

86% of runaway children who are child trafficking victims are in the care of social services or the foster care system.

1 in 2 kids who age out will develop a substance dependence.

7 in 10 of girls who age out will become pregnant before the age of 21.

#### **GOD'S PLAN FOR THE CHURCH**

## THE VILLAGE HAS A PLAN FOR VULNERABLE CHILDREN

Chestnut Mountain Village ('The Village') guides and equips churches to care for vulnerable children and families through a proven, step-by-step ministry model that amplifies the Gospel, nurtures spiritual growth and involves the entire church.

#### **FAMILY ADVOCACY MINISTRY**

The proven model used by The Village is called Family Advocacy Ministry ('FAM'). FAM is a ministry model designed to help church partners care for vulnerable children in their communities. These ministries allow churches to have a positive impact by:

- · Recruiting & supporting families to care for foster kids
- · Meeting physical and financial needs of foster and vulnerable families
- · Ministering to families to meet emotional and spiritual needs
- · Serving foster and adoptive families in Care Communities

#### **BUILDING CARE COMMUNITIES**

Care Communities are a primary element of FAMs. In Care Communities, volunteers wrap around families to provide support to foster, adoptive and other families through activities such as bringing weekly meals, supplying practical needs, providing transportation, mentoring and tutoring children, and becoming trained to provide child and respite care.

#### A PROVEN MODEL

The national average of families who continue fostering after their first year is about 50% and 80% of foster families are no longer fostering after two years. However, when supported by a FAM, 90% of families continue fostering into a second year. FAMs have a positive impact on both retention and recruiting of foster families and are in place in nearly 700 churches in more than 20 states.

#### Founder and Executive Director, Chestnut Mountain Ranch

Recognized as one of the top 3 leaders in the country by the 2016 John C. Maxwell Leadership Award committee, Steve Finn witnessed first-hand how God makes the impossible possible. After 12 years as a gangs special unit metro-Atlanta police officer, he and his wife felt led to full-time ministry. Following a short tenure as houseparents for Eagle Ranch Children's Home outside of Atlanta, Steve took an even greater leap. Today, he is the Founder and Executive director for Chestnut Mountain Ranch, a 300-acre Christ-centered home and school for boys in one of the poorest areas of the country. Cautioned that building a ministry of such magnitude in that area would be almost impossible, Steve chose to trust that God would bring the seed He had planted to harvest. Together, he and his wife, Dawn, call Chestnut Mountain Ranch home with a family too big to name.

#### **GREG CLUTTER**

After a 30-year career in business and non-profit leadership roles, Greg joined Chestnut Mountain Ranch as Director of Foster Care Initiatives in 2021. Prior to joining the Ranch, Greg served for several years as Chief Operating Officer at a successful West Virginia based research and development services firm focused on chemical, energy, environmental, and software technologies. In that role, he had leadership responsibilities over functions including accounting and finance, information technologies, human resources, marketing, and legal disciplines.
